#### FAMILY COUNSELLING UNIT

Our services will be provided in a manner that is respectful to the Anishinaabe culture and traditions. We will strive to engage the First Nation Service providers and referral sources in all steps of service delivery.

#### **Short Term Crisis Counselling**

This is a brief service with a primary intent to support and stabilize clients (0-18) who have experienced, or are experiencing a crisis or trauma.

#### **Family Counselling**

This service is designed to assist families in identifying issues and developing strategies that can be implemented to preserve and strengthen the family unit.

#### **Adolescent Counselling**

This service is intended to provide youth with support in building self-esteem, empower them to make healthy life style choices in a therapeutic environment where they can feel safe, cared for and understood.

#### **Child Development Support Services**

This service will assist care givers, guardians, and families in understanding the stages of child development and the development of appropriate strategies and techniques to implement in everyday life. Supporting children with complex needs or developmental issues and advocating with other professionals that may be involved with the client.

#### **Group Therapy**

As required or requested, the Family Counsellors may or will organize and conduct group therapy sessions for a specific target group.

#### **Support Services**

At time to time Family Counsellors may be called upon to provide input or feedback or to act as a resource regarding cases at the community level.

#### **Education and Awareness**

These services will be provided to the community on specific issues. The services will focus on individual or group needs to increase understanding of issue.

#### NANAANDAWEWENIN VISON

"The Nanaandawewenin Team recognizes that the children and families we work for are first and foremost in all that we do. We are bound by traditional Anishinaabe teachings. For this reason alone, we strive to give to each other from the heart because the heart is a place of truth."



#### **OUR SERVICE**

The WFS Family Counsellor program does not duplicate services being provided at each of the 10 First Nations. This program is in no way meant to replace the Family Counsellor program that is funded at the community. The primary duties of the WFS Family Counsellors are to provide intensive brief counselling and/or services to children with multiple and/or complex needs and their families. Children in care that are currently presenting a need for treatment can also be referred to WFS Family The WFS Family Counsellors. Counsellors will respond to any youth in the Rainy River District School System that are presenting with suicide risk. The WFS Family Counsellor program may at times provide group and/or family based programs that can be accessed by CCP Program or families.

## WHO IS ELIGIBLE AND HOW DO I ACCESS SERVICES?

This services are open to members of the Fort Frances Tribal Area through a referral process. Potential referral sources can be the following: First Nations, Tribal, Maintstream social service delivery agents, and Rainy River District School System.

All referrals will be processed and responded to in a timely manner by W.F.S personnel.
